# **Author Instructions for Manuscript Preparation**

## International Journal of Pharmacy and Allied Fields

The International Journal of Pharmacy and Allied Fields (IJPAF) is a peerreviewed, multidisciplinary journal dedicated to advancing research in
pharmaceutical and allied sciences. IJPAF aims to enhance the visibility and
impact of high-quality research across academia, industry, and clinical
domains, with a strong focus on originality, scientific rigor, and relevance. The
journal publishes Original Research Articles, Review Articles, and Short
Communications in all major areas of pharmaceutical sciences from drug
formulations to clinical evaluation and administration. Core subject areas
include: Pharmaceutics and pharmaceutical technology; Pharmacology and
toxicology; Pharmacognosy and phyto-chemistry; Pharmaceutical chemistry;
and medicinal chemistry; Clinical and hospital pharmacy; Industrial pharmacy;
Pharmacy practice and community pharmacy; Pharmaceutical biotechnology;
Regulatory affairs and quality assurance;
Drug delivery systems and
nanotechnology;
Biomedical sciences and pharmaceutical education;
Public
health and Pharmacoeconomics.

IJPAF follows a Quarterly publication schedule, releasing issues after every 3 months or 4 times in a year.

#### **General Guidelines**

Manuscripts submitted to IJPAF must contain original, unpublished work that is not simultaneously under consideration elsewhere. Submissions are accepted from authors worldwide, provided the manuscript is written in English. The recommended manuscript length is up to 15 pages, and authors are encouraged to present their findings clearly and concisely. In the cover letter, authors must specify whether the submission should be categorized as a Research Article, Short Communication, or Review Article.

## **Peer Review Policy**

IJPAF follows double-blind peer review process to ensure the publication of high-quality scientific work. Each manuscript undergoes evaluation by a minimum of two independent reviewers. Reviewers are requested to complete their evaluation within 15 days. If a reviewer is unable to meet the deadline, the manuscript will be reassigned promptly. Authors may suggest two potential reviewers (from outside their institution) without any conflicts/favour, while the editorial team have the option to review the manuscript by Author suggested reviewers or assign the manuscript to reviewers from the journal's reviewer database. Reviewers assess manuscripts based on journal guidelines, including clarity of writing, methodology, accuracy of references, scientific validity, and overall presentation. The final decision regarding acceptance or rejection is based on reviewer recommendations and editorial board member's assessment. Authors will receive all communication including decisions, revisions, and updates by email. Regular monitoring of the registered email address and Journal submission portal is advised.

## Submission of Manuscript

Authors must submit manuscripts only through the journal's online submission system. Submissions should be prepared in: MS Word (2003 or 2007 version) Accompanied by a PDF copy of the completed and signed Author License and Publishing Agreement and Publication Forms.

## File Size and Length

Manuscripts should not exceed 20 pages, unless scientifically justified. Authors may be asked to provide a rationale if the length surpasses the standard limit. The MS Word file size must not exceed 10 MB at the time of submission.

#### **Language Requirements**

All manuscripts must be written exclusively in English. Submissions in any other language will not be processed.

#### Font type

Articles should be typed in single line spacing with the following font pattern: Font Type: Times new roman

Size: For heading or title: 14 points and Bold (Small Letters, not capitalize the titles unnecessarily unless required, e.g. HPLC, HPTLC, UV, GC, TLC, SEM, TEM, etc.)

Author/ Coauthor's name: 11 points and Bold Affiliation/ Institute name: 10 points

For Subtitles: 11 points and Bold Content of Manuscript: 10 points Table title and Content: 8 points

#### **Submission Sequence and Manuscript Preparation**

Page 1 should contain only the article title, author names, and affiliations; Page 2 should include an abstract of 200–400 words followed by at least three keywords; and Page 3 onward should consist of the full manuscript text along with all tables and figures appropriately placed within the document, followed abbreviations. acknowledgements, The manuscript must be arranged in the order: Title Page, Abstract, Keywords, Introduction, Materials and Methods, Results, Discussion, Conclusion (if the Results and Discussion sections are combined), Acknowledgements (if applicable), and References. The Title Page should present a concise and informative title, full author details, and complete contact information for the corresponding author. The Introduction should explain the background and significance of the study with support from relevant and recent literature. The Materials and Methods section should provide clear, detailed, and reproducible descriptions of materials, analytical techniques, statistical methods, and experimental procedures. The Results section must avoid duplicating data presented in tables and figures, and should not repeat large sets of numerical values or include unnecessary explanations. The Discussion should interpret and relate the findings to previous work without repeating content from earlier sections. A brief Acknowledgements section may be included if necessary.

All references must follow the journal's prescribed citation format.

#### References

All references must be cited in the text using Arabic numerals in superscript format, and the complete reference list should be arranged in the order in which the citations appear within the manuscript. For sources with three or more authors, only the first author's name should be listed followed by "et al." References to journal articles, books, book chapters, and other sources should be formatted according to the standard citation style prescribed by the journal.

#### Figures:

All figures, whether photographs or illustrations, should have clear contrast between dark and light areas. Figure legends must be concise yet complete and self-explanatory, allowing readers to understand the results without referring to the main text. Legends should be placed directly with the figures, and all figures must be numbered sequentially. Figures should be embedded in the manuscript at their appropriate locations rather than submitted separately. The figure number and title should appear below the figure, and the title should clearly describe the content and findings presented.

#### Tables:

Tables should be numbered consecutively and formatted with grid lines. Large tables may be divided into two or more sections to fit the page layout. Table widths and cell sizes should be uniform, with all content left-aligned. The table number and title should appear above the table, without borders or shading, and tables should not be placed on separate pages. Each table must have a brief but complete, self-explanatory caption, enabling readers to interpret the data independently. Avoid repeating information already presented in figures.

#### **Ethics and Consent**

For studies involving human participants, authors must confirm that all procedures were conducted in accordance with the ethical standards of the relevant institutional or national committee on human experimentation. Patient names, initials, or hospital numbers must **not** be included, particularly in any figures or illustrative material. Research involving animals or clinical trials must receive prior approval from the appropriate institutional animal care or human ethics committees.

## Conflict of Interest and Plagiarism Declaration

Authors are required to disclose any potential conflict of interest (Yes/No) at the time of manuscript submission. This declaration should be included either before the references section or as part of a separate statement. Authors must submit a plagiarism report generated using any recognized plagiarism detection tool along with their manuscript. This ensures that the submitted work is original and properly cited.

## **Article Processing Charges**

The International Journal of Pharmacy and Allied Fields (IJPAF) does not charge any Article Processing Charges (APC) or open access fees. Authors, including the corresponding author, are not required to pay any fees for manuscript submission, processing, or publication. Upon acceptance, the published PDF of the manuscript will be provided to the corresponding author via email. There are no charges for co-authors either.
